NOTIFICATION

No.SOR-III(S&GAD)1-13/2016. In exercise of the powers conferred under section 23 of the Punjab Civil Servants Act, 1974 (*VIII of 1974*), Governor of the Punjab is pleased to make the following amendments in the Home Department (Directorate of Monitoring) Service Rules 2019 with immediate effect:

AMENDMENTS

In the Home Department (Directorate of Monitoring) Service Rules 2019, in the Schedule:

- (1) at Sr. No. 1. [Director General (BS-20)]:
 - (a) in column 5, for the existing entries, the following shall be substituted:

“Retired Officer not below the rank of Brigadier or equivalent rank from Armed Forces having Bachelor degree (second division) or equivalent qualification from an institute or a university recognized by the Higher Education Commission.


OR

 - (i) Master degree (second division) in Sociology or Criminology or Strategic Study or Project Management or Political Science or Public Policy or Mass Communication or Information Technology or Business Administration or Public Administration from a university recognized by the Higher Education Commission; and
 - (ii) Twenty years leadership and management experience in a public sector organization.”; and
 - (b) in column No. 9, for the figure “55”, the figure “60” shall be substituted.
- (2) at Sr. No. 2 [Additional Director (BS-19)], in column 5, for the existing entries, the following shall be substituted:
 - “(i) Master degree (second division) in Sociology or Criminology or Strategic Study or Project Management or Political Science or Public Policy or Mass Communication or Information Technology or Business Administration or Public Administration from a university recognized by the Higher Education Commission;
 - (ii) ten years management and leadership experience in a public sector organization out of which seven years experience related to monitoring and evaluation; and
 - (iii) proficiency in MS Office.

OR

 - (i) Retired Officer not below the rank of Colonel or Lieutenant Colonel or equivalent rank from Armed Forces;
 - (ii) Basic Intelligence Course qualified; and
 - (iii) three to five years experience in security matters.”.
- (3) at Sr. No. 3 [Deputy Director (BS-18)], in column 5, for the existing entries, the following shall be substituted:
 - “(i) Master degree (second division) in Sociology or Criminology or Strategic Study or Project Management or Political Science or Public Policy or Mass Communication or Information Technology or Business Administration or Public Administration from a university recognized by the Higher Education Commission;
 - (ii) seven years management and leadership experience in a public sector organization out of which five years experience related to monitoring and evaluation; and
 - (iii) proficiency in MS Office.
